skills, knowledge, and attitudes to effectively facilitate learning and promote the holistic development of their students. The curriculum, designed by the National Commission for Colleges of Education (NCCE) and the National Universities Commission (NUC), encompasses theoretical knowledge, pedagogical skills, and practical teaching experiences. Teacher Education Program (TEP) combines theoretical and practical experiences provided through various channels such as Colleges of education and Universities. TEP curriculum covers multiple domains to prepare prospective teachers to teach basic education curricula (NCCE, 2020). The TEP curriculum was designed to prepare individuals for teaching careers across all levels of education. It includes pre-service and in-service training, aiming at equipping educators with specialised knowledge, positive attitudes, and practical pedagogical skills. These competencies enable them to effectively plan and deliver curriculum content, shaping the lives of younger generations per societal demands (Kayode, 2015; Yusuf, 2022).

Various institutions, including Colleges of Education, Faculties of Education in universities, and the National Teachers' Institute, are involved in delivering TEP. They offer a range of qualifications from National Certificates in Education (NCE) to bachelor's, master's, and doctoral degrees in education. As of 2021, there were 220 Accredited Teacher Training Institutions in Nigeria, as summarized in Figure 1.1.

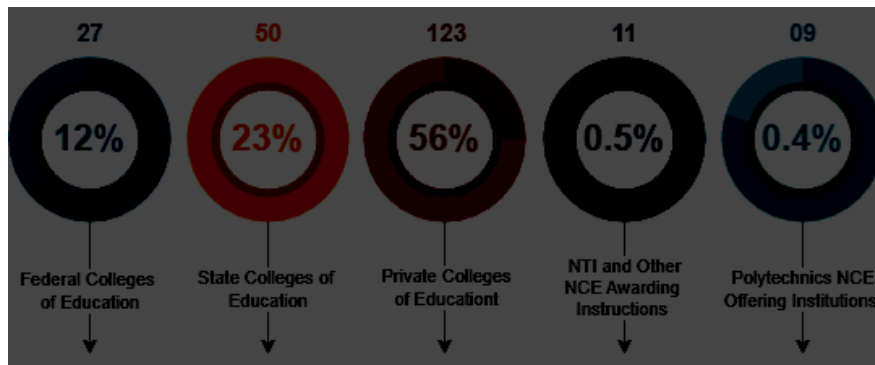


Figure 11 Distribution of Teacher Training Institutions in Nigeria

State of Teacher Education in Nigeria

Despite several reforms to reimagine education system in Nigeria, the current state of Teacher Education is marked by significant deficiencies that threaten the quality of education in the country which demands urgent attention. A study on the challenges of Teacher Education in the 21st Century Nigeria report on demonstrated that the mode of teaching in Nigerian higher education institutions is outdated and fails to address the needs of contemporary students. Additionally, the report notes that minimal learning takes place within these institutions, attributed to the limited collaborations and interaction between students and lecturers (Cherechi, 2018). Several studies expressed concern regarding the prevalence and over-reliance on traditional instructional approaches to education (Abosede et al., 2022; Bakare, 2021; Bature, 2020; Faruk Umar, 2022; FME, 2014, 2022; Okoro & Hedima, 2022). Recent study reaffirmed that currently, the Nigerian education curriculum is lacking flexibility to meet the diverse needs of learners and the country's developmental needs (Angwaomaodoko, 2023).

Moreover, many teacher education institutions in Nigeria suffer from inadequate funding, leading to insufficient infrastructure, outdated teaching materials, and limited access to modern educational technologies (Adeniji et al., 2023). Additionally, opportunities for continuous professional development are scarce, resulting in outdated teaching methods and a lack of exposure to current educational trends and practices (Yusuf, 2022a). Furthermore, enrolment and retention in teacher education programs also present additional challenges. There is a notable gap between the number of teachers needed and the number of enrolled students in most TEP. The teaching profession is often perceived as less attractive compared to other careers, affecting both enrolment and retention rates (Yusuf, 2022b).

There are multiples Interactive Simulations and Virtual Labs online that can compensate for the lack of physical laboratories and equipment by allowing students to perform experiments and simulations in a virtual environment, thereby enhancing their practical learning experiences.

Secondly, to overcome the deficiencies associated with standardized traditional approaches and create more engaging learning opportunities for diverse learners, blended learning was advocated to enhance flexibility, active participation, personalisation, and collaborative learning opportunities (Bryan & Volchenkova, 2016; Garrison & Kanuka, 2004; Manwaring et al., 2017; Olatunde-Aiyedun & Adams, 2022). Studies have also demonstrated that implementing blended learning strategies could lead to improved engagement, satisfaction, and higher levels of academic achievement. Zhang et al., 2022). Integration of UDL strategies in BL design and delivery were found to boost engagement and improve learning outcomes in several educational contexts (Ginting et al., 2022; Janse et al., 2022; Lawless, 2019; Medina, 2018; Zhang & Lee, 2020).

Thirdly, providing teachers with regular training and workshops on the use of educational technology can help them integrate technological resources and ideas into their teaching practices effectively. The Massive Open Online Courses (MOOCs) and webinars can also provide teachers with access to professional development opportunities from anywhere in the world. These courses

cover a range of topics, from pedagogical strategies to subject-specific content and technological integration.
